Pursuant to call of the Board of Supervisors, the Annual Meeting of the Landowners of the Flaghole Drainage District was convened in the offices of Hilliard Brothers of Florida, Ltd., 5500 Flaghole Road, Clewiston, Florida, January 29, 2021.

Mr. Bryan R. Hilliard, acting as Temporary Chairman, called the meeting to order. The Temporary Chairman called on the Secretary to read the resolution of the Board of Supervisors, calling this meeting and to present the Affidavits of Publication of Notice. The Affidavits of Publication were presented to the landowners for their review. Motion was made and carried, ordering the Proofs of Publication filed with the records of the District by attaching same to the minutes of this meeting. The Temporary Chairman stated that the next order of business was to determine that a quorum was present. It was determined that as long as one landowner was present that an official meeting could be held.

The Temporary Chairman stated that the next order of business was the election of permanent officers to conduct the meeting and nominations were in order. Mr. Bryan R. Hilliard was nominated by Paul Allen and without opposition elected Chairman of the meeting.

The Permanent Chairman, Mr. Bryan R. Hilliard called for the reading of the minutes of the last Landowners' Meeting held January 29, 2019. The minutes were read and upon motion made by Paul Allen, approved as presented.

The Chairman stated that Mr. Bryan Hilliard's term as supervisor was expiring. Nominations from the floor for the office of supervisor were requested. Motion was made by Paul Allen, seconded by Joe M. Hilliard II and carried nominating Mr. Bryan Hilliard. There being no further nominations, motion was made and carried, that Mr. Bryan Hilliard be elected by acclamation.

After brief discussion, upon motion made by Paul Allen and seconded by Bryan Hilliard, the Treasurer's report and bills were approved as presented.

The Chairman then stated that the next order of business was to receive the reports of the officers of the District.

Tommy Perry advised that Hendry County is commencing construction on the force main extension from the City of Clewiston Wastewater Plant to Airglades Airport. It is currently not slated to reach the district this year due to funding.

The South Florida Water Management District is replacing the G-96 structure and have discussed passing water through Flaghole during the dry season if needed during the construction.

Perry advised that his office was contacted by the Florida Department of Environmental

Protection (FDEP) regarding the Basin Management Action Plan (BMAP) requirements for lands within the Caloosahatchee River and Estuary Basin. FDEP is requiring all water control districts to submit a Best Management Practices (BMP's) plan to limit nutrients in the water control districts runoff. A plan was submitted and accepted by FDEP and as the process continues updates will be provided. An agenda item for public education and outreach has been added to the landowners meetings as a part of the District BMP implementation.

Upon motion made by Paul Allen and seconded by Bryan Hilliard the engineers and the managers reports were approved as presented.

The Chairman then opened the meeting to any other business that might properly be brought before the Landowners.

There being no further business, upon motion made and carried, the meeting was adjourned.
