Mr. Bryan R. Hilliard, acting as Temporary Chairman, called the meeting to order. The Temporary Chairman called on the Secretary to read the resolution of the Board of Supervisors, calling this meeting and to present the Affidavits of Publication of Notice. The Affidavits of Publication were presented to the landowners for their review. Motion was made and carried, ordering the Proofs of Publication filed with the records of the District by attaching same to the minutes of this meeting. The Temporary Chairman stated that the next order of business was to determine that a quorum was present. It was determined that as long as one landowner was present that an official meeting could be held.

The Temporary Chairman stated that the next order of business was the election of permanent officers to conduct the meeting and nominations were in order. Mr. Bryan R. Hilliard was nominated by Jim Snively and without opposition elected Chairman of the meeting.

The Permanent Chairman, Mr. Bryan R. Hilliard called for the reading of the minutes of the last Landowners' Meeting held February 01, 2017. The minutes were read and upon motion made by Jim Snively and seconded by Paul Allen, approved as presented.

The Chairman stated that Mr. Bryan Hilliard's term as supervisor was expiring. Nominations from the floor for the office of supervisor were requested. Motion was made by Jim Snively, seconded by Paul Allen and carried nominating Mr. Bryan Hilliard. There being no further nominations, motion was made and carried, that Mr. Bryan Hilliard be elected by acclamation.

After brief discussion, upon motion made by Jim Snively and seconded by Paul Allen, the Treasurer's report and bills were approved as presented.

The Chairman then stated that the next order of business was to receive the reports of the officers of the District.

Tommy Perry advised that Hendry County is proposing to extend a force main from the City of Clewiston's wastewater plant to the Airglades airport. His office has been contacted to discuss preliminary plans and the specifications the district would require regarding the district right of ways. During the past year his office has assisted in the submitting of quarterly reports documenting the districts monthly water use as required by the consumptive use permit 26-001139-W. As far as he is aware all the district facilities have performed as expected this year.

Upon motion made by Jim Snively and seconded by Paul Allen the engineers and the managers reports were approved as presented.

The Chairman then opened the meeting to any other business that might properly be brought before the Landowners.

There being no further business, upon motion made and carried, the meeting was adjourned.
